### III. Old Business

• Update on Hiring Process – Executive Director (Lanna)

The Executive Director position is scheduled to post on April 27<sup>th</sup>. It is being posted in multiple locations, including typical resume/career websites, the MCCCD website and with relevant compliance and authorization organizations. Those sites that require payment for listings will be paid for from the Arizona SARA Council budget. Review of applications will begin in two weeks. Joel and Lanna will do first reviews. When final candidates are selected, they will be brought in for interviews, to include time with the entire Council.

#### IV. New Business

• Review of Institutional Applications (Joel)

This is the Council's first official review of applications for membership in NC-SARA. In discussion surrounding the applications that have been submitted and the developing process by the Council for approval, the following recommendations are made:

- 1. Add additional verbiage to the Arizona SARA Council website to ensure institutions applying for membership understand the proper way to record FTE counts both overall (full time vs. part time, multiple locations, etc.) and in relation to the bonding requirement (for non-Arizona students in SARA states in online programs only)
- Clarify what financial documents need to be included with an application and acknowledge that institutions that are not Title IV eligible do not need to provide an audit or a financial composite score
- 3. Require institutions to print a copy of their Statement of Affiliation Status (SAS) (if applicable) and include it with their application

The Council will adopt the following criteria in evaluating the financial stability of institutions that are required to provide financial documents with their application:

- Most recent USDOE financial responsibility index score, if applicable. Institutions that have a composite score between 1.0 and 1.49 are subject to additional submissions as specified on Page 8 of the Arizona SARA application
- 2. Net income projections from the institution's consolidated statement of income and retained earnings
- 3. An institution's current ratio of operating income to operating expense
- 4. Relevant audit notes included with the institution's financial statements
